**Your Interest Rate is variable and may change automatically from time to time according to the variable rate terms set forth in this Addendum.** The Interest Rate is subject to change on the first day of the billing cycle monthly to reflect any change in the Index and will be determined by the Prime Rate on the first day of the month as published in *The Wall Street Journal* "Money Rates" table to which we add a margin. The Interest Rate will never be greater than 18.00%. Any increase in the Interest Rate will take the form of additional payments shown as Total Minimum Payments on the statement. If the Index is no longer available, the Credit Union will choose a new index which is based upon comparable information.

Fees

<b>Transaction Fees</b>	
- Cash Advance	3.00% of the amount of each cash advance
- Foreign Transaction	1.00% of each transaction in U.S. dollars
<b>Penalty Fees</b>	
- Late Payment	\$25.00 when minimum payment is not made within ten (10) days of payment due date
- Returned Payment	\$25.00

<b>Other Fees</b>	
- Card Replacement	\$5.00
- Document Copy	\$5.00
- Rush	\$50.00
- Emergency Card Replacement	\$200.00
- Pay-by-Phone	\$10.00

**Balance Transfers.** We may permit you to transfer the balance of an account that you owe to another creditor to your account with us. If we approve a balance transfer, finance charges will be calculated and will accrue according to the same method as for cash advances.

**Method for Computing the Balance for Purchases:** Average Daily Balance (Including New Purchases)

**Minimum Payment.** Your monthly payment will be 3.00% of your total new balance, or \$20.00, whichever is greater plus outstanding unpaid fees and charges, all prior unpaid payments and any amount that exceeds your credit limit.
